 Modified the error message in the pop-up error screen that is currently displayed when PA data has not yet been added. Added Section numbers to the pop-up error screen. Added a Print button to the pop-up error screen. Added a verification step when affiliate attempts to send AOR to RA. 		
P3 & CAM AORs – Changes to Signatures functionality	Enhancement	244766
On the Signatures screen, instead of having US Tie Print Name as an open text field, it is now display-only, filled with the US Tie Name from the US Tie screen. The Affiliate Print Name is now stored as soon as the user saves the few fields that are required when starting a new AOR, removing the requirement to save the data on the Signature screen before sending the AOR to the RA.		
Lautenberg AORs – Changes to Signatures functionality	Bug	244923
There was a recent change in IRIS to add Signature Print Names to the printable FSU AOR. The name of the agency rep who originally created the AOR was being added to the form. It was learned that there may be times when a different agency rep name should be in the Signature Print Name. Therefore, a Signatures tab has been added to Lautenberg AORs, which will function the same way it does for P3 and CAM AORs.		
P3 AOR - fixed "Place of Marriage" bug	Bug	244749
Corrected bug in Section III of the P3 AOR. When "Date of Marriage" is set to Unknown, IRIS automatically adds Unknown to "Place of Marriage." The user should be able to modify it, but IRIS was not allowing that.		
Dashboard Notification - "AORs Accepted by RA" modification	Bug	245353
Removed sentence at the top of the notification that said, "Note: For Lautenberg AORs, mail hardcopy of the AOR to the RA." Hard copies no longer have to be mailed to the RAs.		
Dashboard Notification – Affiliate "AOR Activities" modification	Enhancement	245370
Changed notification so it will only display red on the dashboard when an Activity requiring acknowledgement has not been acknowledged after a week or more on the list.

Standard Report - FY/CY Arrivals by Affiliate and Site Report	Enhancement	244883
Modified the FY/CY Arrivals by Affiliate and Site Report to include separate sections for Refugee totals and SIV totals. For example, when exporting to Excel, there used to be two tabs: "Ref+SIV" and "URM." Now there are four tabs: "Refugee + SIV," "Refugee," "SIV," and "URM." The main tab (i.e. "Refugee + SIV") still includes the totals of refugees and SIVs combined.

User Maintenance - Deactivating Unused User Accounts	Enhancement	244885
Created a daily scheduled job to toggle through user accounts and mark them as Inactive and Locked if the user has not logged on in 90 or more days. There was already a process in IRIS where a user is not able to log on if inactive for 90 days or more. However, the user account status is not changed to inactive until they attempt to log on, leaving many user accounts appearing to still be active even though the user would not be able to get into IRIS.		
IRIS Test Instances – remove IP Address Requirement	Enhancement	245438
Since IRIS Test Instances are now hosted in HTTPS (secure) rather than HTTP (non-secure), the requirement of each user's IP Address needing to be recorded in IRIS Test has been removed.		
IRIS Case table - Added new field	Enhancement	245436
Added a new field to the IRISCase table called RPC_RecordVersion. RPC will eventually be providing biodata from their new START system, which will be replacing WRAPS. Data from START will come through as Version 002; data coming from WRAPS will continue to contain Version 001. We added the field in advance of other changes that will need to be made to IRIS during the START project.
